Commissioner Belisle suggested to ask him to join to lay the groundwork and understanding of the commission's work and his work and potentially an eventual public forum or community event.

Governor Walz Budget: He just announced his budget and is proposing an increase in Human Rights Budget and also proposing an office in Rochester. Rochester Public School Board met this week and the superintendent distributed data on discipline which indicated that the numbers are going in the wrong direction, disparities are getting worse not better. There is a superintendent listening session next Monday, February 25th and if commissioners can attend to please do so.

Enhanced Driver's License and Homeless: Commissioner Manal brought this topic up and would like to add it to the next agenda.
