- Water Supply Well ----- \$304.00 County Fee + \$5.00 State Fee = \$309.00
- Dewatering ----- \$304.00 County Fee + \$5.00 State Fee = \$309.00
- Environmental Well (existing) (Site Sealing \$875 max) (Monitoring) --- \$175 County Fee + \$5.00 State Fee = \$180.00
- Environmental Well <72 hours, >25' depth (Temporary) ----- \$175 County Fee + \$5.00 State Fee = \$180.00
- Environmental Well <72 hours, between 15'-25' depth (Temporary, no surcharge) (Environmental Bore Hole) ----- H-Series = \$25.00
